- b) "Institute" on his part is interested in entering into the business of operating as a service provider through their Area marketing outlet and thus carrying out the business of providing services to the Students.
- c) **Glister Eduversity** is desirous of appointing "Institute" to conduct, manage and operate the services through the **Director** as per the uniform norms set up by an educational sector in respect of nature of services and cost of services to the students.
- d) "Institute" is desirous of taking over the services offered by Glister Eduversity for the purpose of its operations and management to carry out business on the terms and conductions contained herein.
- e) The purpose of this Agreement is to set forth the terms and conditions under which the parties to the Agreement shall conduct themselves during the substances of Agreement.

NOW, THEREFORE, the parties, in considerations of the convents, undertakings and commitments set forth therein here by mutually agree as follows,

Section 1: Definitions and Interpretations

For the purpose of this agreement, the following expressions shall bear the respective meaning set forth below,

Section 2: Grant of the Authorization

- 1. The "Institute" warrants and represents to Glister Eduversity that it is a company / firm, validly existing and a good standing under the laws of republic of India and has all requisite power and authority enter into this agreement with to All the obligations of the "Institute" under this agreement are legal, valid and binding obligations enforceable in accordance with its terms. There are no proceedings pending against the Institute, which may have an advice effect on the ability of the Institute to perform and meet its obligations under this agreement.
- 2. There is no product and/or service and/or territorial exclusivity granted to the "Institute" as part of this Agreement by **Glister Eduversity** may give such right or a similar right to persons other than "Institute" to makes associate anywhere including geographic area surrounding the premises.

Section 3: Services, Terms & conditions

- 1. **Glister Eduversity** would provide their entire range of services by own or through the service providers which includes online ads, offline ads, value added services and premium services to the "Institute".
- 2. "Institute" will act as a single point for all the services provided by **Glister Eduversity**falling within the purview of this agreement.
- 3. All the services falling within the purview of this agreement will be made to "Institute" based upon standard conditions of sales as set by **Glister Eduversity** for all its "Institute" outlets from time to time.
- 4. "Institute" will keep providing the services within the purview of this agreement through their outlets exclusive with **Glister Eduversity**" Institute" will not enter into direct agreements with any other services providers, aggregators, distributors or any similar entity in India for this purpose, for the duration of this agreement.
- 5. The Intellectual Property rights including the concept of delivery of services will rest with **Glister Eduversity** or its service providers.
- 6. **Glister Eduversity** and "Institute" shall conduct their business at all times, in accordance with the applicable statutes, regulations, notification etc., Issued by the Government or any other statutory authority.

- 8. Courses: The all courses will be designed by Institutes and should not be other than Computer Education, Fashion Designing, Media, Management, Taxation and Accounting and quality.

Section 4: Confidentiality

- 1. "Institute" shall keep all information of confidential nature received from the **Glister Eduversity** in whatever form as strictly confidential and shall not disclose it to third Parties.
- 2. "Institute" agrees not to disclose revenue Information without **Glister Eduversity** prior written consent.

Section 5: Limitation of liability

The Parties shall not be liable for any incidental, special, indirect or consequential damages arising out of or relating to this Agreement.

Section 6: Terms

This Agreement comes into force on the date of signing this Agreement and shall continue for three (3) year after this date. This agreement may be extended on the mutual agreement of both parties, unless earlier terminated in accordance with the agreement by paying renewal fee to **Glister Eduversity** by "Institute".

Section 7: Termination

- 1. This agreement may be terminated by either party at any time, without assigning any reason by giving prior written notice of ninety (90) days.
- 2. **Glister Eduversity** shall be entitled to terminate this agreement, with immediate effect upon happening of one or more of following:
 - Failure of the "Institute" to provide the services to the customers as per the expectations of **Glister Eduversity.**

Section 8: Applicable Law

This aggreement is governed by and constructed in accordance with the laws of india.

Section 9: Dispute Resolution and Jurisdiction

- 1. Any dispute, controversy or claims arising out of or relating to this Agreement or the breach, termination or invalidity thereof, shall be settled by arbitration in accordance with the provisions of the [Indian] Arbitration and Conciliation Act, 2013.
- 2. The arbitral tribunal shall be composed of three arbitrators, one arbitrator appointed by **Glister Eduversity** a second arbitrator appointed by "Institute" and a third arbitrator to be appointed by such arbitrators.
- 3. The arbitral procedure shall be conducted in the English/Hindi language and any award or awards shall be rendered in English/Hindi. The procedural law of the arbitration shall be Indian law.
- 4. The award of the arbitral tribunal shall be final, conclusive and binding upon the Parties, and the provisions of the [Indian] Arbitration and Conciliation Act, 2013 shall apply.
- 5. The rights and obligations of the Parties under, or pursuant to, this Clause, including the arbitration agreement in this Clause, shall be governed by and be subject to Indian law, and the agreement shall be subject to the exclusive jurisdiction of the courts at Varanasi.
